MINIMIZING MRO CHEMICAL RISK

SARA Section 313 Chemical Reporting Program

Managing the annual SARA Title III report for a large industrial site can be a time-consuming and costly practice. The SARA Title III Report is a federal requirement for facilities that use certain toxic chemicals in quantities above threshold levels and have at least 10 employees. They are required by law to report annually on the use, release, and disposal of those chemicals, and to compile data into a Toxics Release Inventory or TRI. Chemicals that require TRI reporting are available in the EPA's List of Lists.

Tracking down the required information from multiple MRO Chemical suppliers quite often is a full time job. For this reason, CRC developed our SARA Section 313 Chemical Reporting Program to improve the management of MRO chemicals, reduce costs surrounding the acquisition, use and disposal of these chemicals,

and keep you in compliance with Federal regulations. Based on your purchasing records through your CRC distributor, our regulatory department will track and calculate these chemicals and provide totals for use in evaluating your annual TRI reporting requirements.

A few key questions to consider...

What are the reportable limits for my facility? How are we tracking MRO chemical usage across the entire site? Are unauthorized MRO chemical purchases being made on the shop floor? How are we tracking formula changes and updating Safety Data Sheets for MRO chemicals used?

Uncertainty on any of these issues could be putting your facility at risk! CRC can help you identify and track which reportable chemicals are used and mitigate your risks.

3 STEP REPORTING PROCESS

PRODUCT SURVEY AND **APPLICATION ANALYSIS**

Contact your local CRC Regional Manager to set up a review of your current maintenance chemical product use. CRC will consolidate products where appropriate to one of CRC's over 1,000 SKUs.

TRACK YOUR CHEMICAL CONSUMPTION

CRC, in partnership with your local distributor, will track your annual consumption of chemicals which are on the EPA's Toxic Release Inventory. Even if not at reportable levels, these chemicals need to be tracked.

CHEMICAL INGREDIENT REPORT IS GENERATED

CRC will provide a complete list of all SARA313 chemical ingredients from your CRC products, along with total annual volume. Use the list to determine your facility's SARA reporting requirements.
